<b>1. Homicide (1a):</b> conduct that results in the death of another person.				
<b>2. Forcible Sexual Offense (2.1a):</b> involving forcible compulsion.

<b>3. Robbery (3a):</b> forcible stealing of property from a person by threatening the immediate use of physical force.				
<b>4. Assault with Serious Physical Injury (4a):</b> intentionally or recklessly causing physical injury which creates substantial risk of death or serious or protracted disfigurement or protracted impairment of health or protracted loss or impairment of the function of any bodily organ.				
<b>5. Arson (5a):</b> deliberately starting a fire with intent to damage or destroy property.				
<b>6. Kidnapping (6a):</b> to abduct a person or restrain a person with intent to prevent his or her liberation.				
<b>7. Assault with Physical Injury (7a):</b> intentional or reckless act causing impairment of physical condition or substantial pain. (In violation of the school district code of conduct).				
<b>8. Reckless Endangerment (8a):</b> subjecting individuals to danger by recklessly engaging in conduct that creates a grave risk of death or serious injury but no actual physical injury.				
<b>9. Minor Altercations (Assaults) (9a):</b> involving physical contact and no physical injury.				
<b>10. Intimidation, Harassment, Menacing or Bullying (10a):</b> no physical contact - intentionally placing another person in fear of imminent physical injury. Incidents that do not result in a consequence (j-o) are reported in Item 2 page 3.				
<b>11. Burglary (11a):</b> entering or remaining unlawfully on school property with intent to commit a crime.				
<b>12. Criminal Mischief (12a):</b> Intentional or reckless damaging of school property or the property of another person, including but not limited to vandalism and the defacing of property with graffiti.

<b>13. Larceny, or Other Theft Offense (13a):</b> unlawful taking and carrying away of personal property with intent to deprive the rightful owner of property. Permanently or unlawfully withholding property from another.

<b>15. False Alarm (15a):</b> falsely activating a fire alarm or other disaster alarm.				
<b>16. Riot (16a):</b> four or more persons simultaneously engaging in tumultuous and violent conduct and thereby intentionally or recklessly causing or creating a grave risk of physical injury or substantial property damage or causing public alarm.				
<b>17. Weapons Possession Only (17a)</b>				
<b>18. Use, Possession, or Sale of Drugs Only (18a)</b>				
<b>19. Use, Possession, or Sale of Alcohol Only (19a)</b>				
<b>20. Other Disruptive Incidents (20a):</b> incidents involving disruption to the educational process serious enough to lead to consequence listed in (j-o).
