COMMUNICATIONS AND ANNOUNCEMENTS

Mr. Finello announced that security cameras have been installed and are working around Abrams Intermediate School. Bureau. Mr. Finello acknowledged the Lowndes Avenue Task Force for their efforts. Mrs. Rogan thanked Mary Stokkers for her diligence as Chairperson of the Lowndes Avenue Task Force for her hard work and commitment.

Mr. Finello discussed the district calendar and the changes made by the Board of Regents and how that may affect the timeline for printing of the calendar.

PUBLIC COMMENTARY

A parent of a student who will be graduating in June 2010 commented on the scheduling of the junior/senior prom on the night before graduation. She would like to change the prom date and gave her reasons.

Three students came up for commentary; one of the students was the speaker for the group. They were editors of the yearbook and discussed the new advisors that were appointed by Dr. Leonardi. They wanted Ms. Piffard to continue as advisor.

Another parent concurred with the previous comments about rescheduling the prom date and asked for an open forum to discuss the issue.

Mr. Dwyer, Mr. Finello and Dr. Leonardi discussed the prom/graduation date issue and agreed to have an open meeting to discuss it and hear all sides.

New Course Adoption (Native Language Arts III)

Mr. Finello explained that information regarding a course, ESL/Bilingual – Native Language Arts III (NLA III) had been sent to the Board for review. This course is designed for English Language Learners (Intermediate level) for Huntington High School. Mrs. Kasper, Director of Foreign Language, ESL & Bilingual Education, then detailed the course that was being presented for approval. Discussion followed.

A MOTION was made by Mrs. Brown and seconded by Mrs. Black to approve the Native Language Arts III course.

Facility Usage Fees

Mr. Grackin indicated that during the budget process there was talk about raising the facilities usage fees. Mr. Grackin presented to the Board fee schedules of other school districts for comparison purposes. Extensive discussion followed regarding how an increase would impact the non-profit organizations using our facilities. Mr. Rispoli, Director of Facilities, answered questions posed by the Board. It was decided that an impact study needed to be done and the Board will review the issue at the next meeting.
