COMMUNICATIONS & ANNOUNCEMENTS

Huntington Station Action Coalition

Mr. Dwyer indicated that on November 9, 2009 the first meeting of the Huntington Station Action Coalition, Supervisor Petrone's advisory group, took place. This meeting was attended by Mr. Dwyer, Mr. Finello, Mrs. Stokkers and various representatives from different facets of the community such as the Economic Development Corporation, police, churches and school and community advocates. Six subcommittees will be formed that will have different areas of concentration. They are:

- a) Huntington Station Revitalization
- b) Immigration Management
- c) Community Organization/Civic Group Development
- d) Policing and Enforcement
- e) Housing and Code Enforcement
- f) Education and Human/Social Services

The next meeting of the Huntington Station Action Coalition will be on December 7, 2009.

Floor Hockey Fundraiser

Mrs. Bené attended a floor hockey fundraiser at the high school played between the Finley and Huntington High School teachers. She thanked the teachers who participated and the students who donated dry goods.

Huntington High School Play

Mrs. Bené also attended the play at the high school that was presented on December 13th and 14th. She thanked all of the students who participated along with Mr. Schwendemann and Mr. Gilbert for all their hard work.

PUBLIC COMMENTARY

Mr. Dwyer reviewed the district's expectations for the Public Commentary portion of the meeting and asked that those who choose to speak limit their comments to three minutes in order to allow time for the board to conduct business. He also asked that each speaker fill out a sheet so there is a record of their comment. He indicated the importance of hearing the comments of the public. He then opened up the Public Commentary:

A teacher and resident read a statement regarding the Assistant Principal position at the high school.

The PTA Council President urged everyone to work together to solve the issues the district is currently facing and commented about the options that were presented by our architects, Burton, Behrendt and Smith, two years ago for solving our space issues.

A resident urged the public to vote on December 22, 2009 for Council Districts. She commented that the safety issue at Jack Abrams Intermediate is a town issue and it is not getting sufficient attention from the town.

ITEMS FOR DISCUSSION/ACTION

External Audit Report

Mr. Grackin explained that annually the district is required to have a financial audit done. He indicated that Jill Sanders of Coughlin Foundotos Cullen & Danowski, our external audit firm, will discuss the results of that audit. Mr. Grackin indicated that the Board of Education will be asked to accept the audit report and the Corrective Action Plan that is the district's response to the audit report. He then introduced Ms. Sanders.

The Financial Reports for the fiscal year ending June 30, 2009 were presented by Ms. Sanders. Ms. Sanders rendered an unqualified opinion that the financial condition of the school district is positive and sound. She commented that there are very good internal controls in place. Ms. Sanders commended Mr. Grackin, Ms. Keegan and the Business Office for a job well done. Discussion followed. Mr. McGrath commented that the report could not have been better and overall things are excellent. Mrs. Black indicated that the Internal Auditor agrees. She thanked Ms. Sanders.
