Mr. Finello indicated that Mrs. Marino attended an award ceremony in Ohio and accepted an award for Southdown Primary School. Representatives from the school will attend the next board meeting.

Members of the community were given the opportunity to address the Board of Education on items on the agenda.

# ITEMS FOR DISCUSSION/ACTION

# Internal Audit Report

Mrs. Black being a member of the Audit Committee introduced the auditors that would be presenting at the board meeting. She indicated that as mandated by New York State, every year the district is audited by internal and external auditors. Robert C. Armbrecht and Patty Nelson of Sheehan and Company, our internal auditors, then reported on the results of their audit for the 2009-2010 year. They reported that they performed a risk assessment in nine areas and had comments in only one area and steps were taken immediately to correct these minor comments.

Ms. Nelson commended Mr. Grackin and the Business Office indicating that she has never in all her career seen a district like this. She uses the Huntington District as a model district.

#### 2010-2011 Tax Rate

Mr. Grackin discussed the process involved in setting the tax levy. There was discussion regarding state aid cuts, reduction in STAR money, the need for \$485,000 in additional revenue to offset these cuts, and assessed valuation. Discussion followed.

A MOTION was made by Mrs. Rogan and seconded by Mrs. Black to appropriate 1,915,000 and place the following amounts in our reserves resulting in an unappropriated fund balance of (4%) \$4,351,461 and placing the following amounts in our reserves (see attached):

Transfer to Capital Reserve: \$2,000,000.00
Transfer to Workers Compensation Reserve: \$65,000.00
Transfer to Unemployment Reserve: \$66,776.83

#### Capital Bid Award/Woodhull

Mr. Grackin distributed a letter from Burton Behrendt Smith, our architects, indicating that it is in the district's best interest to re-bid the project in its entirety.
