NON-PUBLIC SCHOOLS TRANSPORTATION REQUEST FORM 2024-2025 SCHOOL YEAR

Residents of the Huntington Union Free School District requesting transportation for their children attending non-public schools must submit a request on or before April 1, 2024 in order to be eligible for this transportation during the 2024-2025 school year. Late requests cannot be honored. Requests for changes in transportation that lead to any additional cost to the district will NOT be honored after April 1, 2024 even if related to change in schools.

FOUR items showing <u>proof of district residency</u> should be submitted to the District Registration Office for all new registrants and for those who may be changing from a public to a private school. In order to qualify for transportation, private school students must register with the Registration Office on an annual basis.

An original birth certificate must be presented for all incoming kindergarten students. (Please do not mail birth certificates.) Children entering kindergarten <u>must be</u> five (5) years of age on or before December 1, 2024.

The Registration Office is located in the administrative wing of the Jack Abrams STEM Magnet School, 50 Tower St. Huntington Station, NY 11746. Registration Office Hours are by appointment only. Registration Office phone number: (631) 673-2974

Current district transportation eligibility limits are as follows:

- · Kindergarten through grade 3: all students eligible
- Grades 4-6: students residing a 1/2 mile or further from the school
- · Grades 7-12: students residing 1 mile or further from the school
- · Maximum transport distance to any school: 15 miles
