October 24, 2011

The Regular Meeting of the Board of Education of the Huntington Union Free School District was held on Monday, October 24, 2011 at Jack Abrams School, Huntington Station, New York. The meeting was called to order at 6:30 p.m.

COMMUNICATIONS AND ANNOUNCEMENTS

Homecoming was an enormous success beginning at the pep rally on Friday, float night, the parade, football game and dance. School spirit is strong.

Mrs. Rogan attended the Booster Club Gold Outing at Indian Hills on October 10, 2011 which was a great success and also attended the Grade 6 rocket launch this past Friday.

Mr. Polansky thanked the Washington students and staff for the invitation to their hoedown and the Southdown students and Mrs. Marino for the Harvest Festival invitation. He attended both events and thoroughly enjoyed them.

Mr. Polansky indicated that the Marching Band season culminates in Syracuse, New York on October 30, 2011 for the final event. He knows they can win it all and wished them luck.

Mr. Polansky commented on Homecoming saying it was the "most spirited homecoming he has ever been a part of" and he has been a part of many. He announced there is a series of Huntington High School visitations set up for parents: November 2, 16 and 30 indicating parents will receive a flyer shortly.

Mr. Polansky attended the Science Honor Society Induction Ceremony on October $19^{\rm th}$ indicating we have so much to look forward to from these talented students. He thanked Mrs. Montesano, Ms. Forbes and Ms. Kenny.

PRESENTATIONS

Siemens Competition Finalist/Semi-Finalist

Mr. Polansky explained what the Siemens Competition is and how great an honor these students have received. He introduced Ms. Kenny who presented Holly Flores, the finalist and Juliana Coraor, the semi-finalist. The students each described their winning projects.

Mr. Polansky presented them with a Certificate of Achievement from the district. They posed for pictures with members of the Board, teachers and the Superintendent.

He explained that there would have to be \$2,500,000 cut from the budget to keep the tax cap at 2%. He explained the difference between tax levy and tax rate. Discussion followed.
