ROLL CALL

Mr. McGrath responded and extensive discussion followed regarding how the position for the principal at the alternative high school was determined and where the funds would come from. Mr. Grackin, Mr. Giani, and Mr. Finello took part in the discussion about the need for an alternative high school that would be in session during the day and would serve the needs of students who currently are not successful. Discussion followed about space and overcrowding and when to expect the study that our architects are in the process of completing.

Carol Leek, PTA member, had questions about the budget and the alternative high school. Discussion followed.

Elaine May, PTSA President, Huntington High School also expressed concerns about the rumors and suggested information be put on the website. Discussion followed. All were in agreement to put information on the website.

Mrs. May also expressed gratitude for the Math course that was offered at Finley Middle School over the summer for students transitioning from Finley Middle School to the High School. The teacher was wonderful and the students were engaged and very successful.
